A resident may purchase a **Temporary Animal Licence**, in the event they are temporarily caring for an animal for a specified length of time. This temporary licence shall not exceed a period of thirty (30) days from the date of purchase. This temporary licence may not be renewed on more than two (2) occasions, per calendar year, per residence. The Temporary Animal Licence is FREE if the animal has existing tags. If requesting a NEW TAG (for an untagged animal), a \$5.00 fee for replacement tags will be applied.

Information and Agreement

For the purpose of this form, Dog / Cat / Animal refer to animals over the age of six (6) months. * A DISCOUNTED FEE applies to annual Animal Licence renewals purchased **before February 17**, or in the case of a new animal, Animal Licenses purchased **within 10 days** of requiring a tag. Animal Licenses are valid until December 31 of each year. A copy of this application and payment must be submitted to the Municipal Office; a secure drop box is available for after-hours submissions. Acceptable forms of payment include cash, cheque or debit.
